**Undertaking by the Racehorse Owners to the Hyderabad Race Club and Turf Authorities of India:**

1. I/we, shall abide by the Hyderabad Race Club and Turf Authorities of India Rules of Racing/Racing Calendar Notifications issued from time to time.
2. I/we, am/are aware of owning of race horse's liabilities/responsibilities and maintenance cost of race horse/s per month i.e. feeding, veterinary bills, salaries to stable staff, racehorse trainers fees etc., and shall sustain to incur the cost financially from my/our own sources of income/funds or otherwise.
3. I/we, shall not depend on the Hyderabad Race Club and Turf Authorities of India for any financial assistance or otherwise/subsidies/any other upkeep cost required for the racehorse/s owned/part-owned by me/us.
4. I/we, shall promptly remit all expenses/fees/sweepstakes/statutory payments on time or as per schedule to the Hyderabad Race Club and Turf Authorities of India/Racehorse Trainer/s and any other registered body as applicable/operating on behalf of the Trainers/Owners.
5. I/we, shall be solely responsible for all statutory payments as applicable/levied by the State/Central Government from time to time on my/our expenses/fees/stakes earned/cups/trophies etc.,
6. I/we, acknowledge/abide by the above conditions or any other terms and conditions issued/notified by the Hyderabad Race Club and Turf Authorities of India from time to time. Any default on my/our part, the ownership of the horses owned/part-owned by me/us shall deemed to be ceased/cancelled and the Hyderabad Race Club or Turf Authorities of India has/have the right to auction such horse/s publicly after issuing a prior notice of 14 days and the dues of the Hyderabad Race Club/Turf Authorities of India will be cleared first and then the Racehorse Trainer/s and then in case of any excess amount received from auction the same will be paid to the concerned Owner/s.

**GUIDELINES FOR APPROVAL OF NEW RACE HORSE OWNERSHIP  
AT HYDERABAD RACE CLUB  
(BOS 22-11-2009, 01-03-2010, 12-06-2017, 08/01/2020, 09/01/2021 &  
25/11/2024)**

**ALL NEW OWNERSHIP SHOULD BE APPROVED BY THE BOARD:**

- 1) Annual Income to be not less than Rs.10 lakhs and income proof and copy of income tax filed for the past 3 years has to be submitted.
- 2) I.T. Assessment for the past 3 years & Professional Tax payment details to be submitted.
- 3) Interest free Security deposit Rs.2,00,000/- to be remitted .
- 4) Copy of latest value of property/lands/plots/buildings assessed by a competent authority.
- 5) Copy of permanent account (PAN) number and Aadhar Card to be submitted.
- 6) Interest in racing and other related equestrian sports.
- 7) Details of business/profession in the last 3 years.
- 8) Details of membership with other race clubs/social clubs.
- 9) Form to be recommended by two (2) existing Racehorse owners approved by the HRC, who have standing record of over 5 years without any obligations.
- 10) If the annual income of the applicant is less than Rs.10(Ten) lakhs and more than Rs.5 lakhs for any year (within block period of three consecutive years), then he/she/they shall remit an Interest Free Security deposit of Rs.5,00,000/- instead of Rs.2,00,000/-.

“EXPLANATORY NOTE WITH REGARD TO THE GENERAL CONDITIONS FOR SALE OF HORSES BY PUBLIC AUCTION IN THE EVENT OF DEFAULT OF A PAYMENT BY OWNERS”.

**EXPLANATORY NOTE:**

- (i) Since the horse/s or the share of an owner/s in any of the horse/s registered in the name of an owner/s is to be sold by the public auction on there being a debit balance in the account of owner/s concerned for two months, after such owner/s has been called upon to make good the same, two such letters by Regd. Post Ack. Due will be sent to such owner/s in advance calling upon him/her/them to make the payment of his/her or their dues before the horse/s or owner/s share/s is put up for sale by public auction.
- (ii) Such public auction will be held as far as possible, only during the Hyderabad Monsoon/Winter Racing Season on a Race Day after the races scheduled for that race day have been run.
- (iii) If any horse/s to be so auctioned does not invite a single bid such a horse/s will be re-auctioned after expiry of a fortnight.
- (iv) If at such second auction also, the horse/s does not invite a single bid, the Hyderabad Race Club and or Trainer would be entitled to give away such a horse/s to a Riding School or to the Biological Evans Limited, or to any person desiring to use the horse/s as a Hack.

*If, however, inspite of efforts to find a home for the horse/s concerned, if it does not become possible to do so, the Hyderabad Race Club will again inform the Owner/s concerned in writing that such owner/s should remove the said horse/s from the premises of Hyderabad Race Club within a fortnight of the date of such letter and also intimate that in the alternative, the Hyderabad Race Club will be reluctantly compelled to put down the said horse/s on humanitarian grounds and in any of the aforesaid events, the Hyderabad Race Club will not be liable or responsible to the Owners concerned in any way of the manner whatsoever.*
